Worshipful Master's Message

Brethren and Friends,

As we get into the month of July and celebrate our country's 238th birthday, I can think of no better time to highlight the impact Freemasons had on the founding of this great nation. I don't think it's an overstatement to say that without Masonry, the very ideals and core values of the United States would not be what they are.

Democratically electing leaders, education, freedom from oppression, selecting one's own religious path, equal justice for all, freedom of assembly, freedom to speak one's mind without fear of reprisal ... those are all principal tenants of our great fraternity. Thanks to the Masonic connections of our Founding Fathers, those same principal tenants are guaranteed rights of all American citizens.

No fewer than 14 American presidents have been Masons. All three Presidents of the United States elected from Tennessee were Masons. One – Andrew Johnson – was a member of Greeneville Lodge, and another – Andrew Jackson – we know for a fact visited our Lodge. George Washington, Benjamin Franklin, Paul Revere, John Hancock, and

many other famous names among those who helped forge our nation were Masons. Nine signers of the Declaration of Independence were Masons. There were 13 Masons who signed the U.S. Constitution. Nearly half of all the generals in the Continental Army were known to be brother Masons. Although there is no proof of Masonic organization of the Boston Tea Party, more than likely Masons were involved.

Some people try to say this proves a vast Masonic conspiracy whereby Masons were, and still are, trying to create a new world order. That's nothing more than fuel for Hollywood movies, radio talk show hosts, and people trying to sell books. I, on the other hand, contend that it is proof of exactly what Freemasonry stands for: liberty and the freedom to choose one's own path in life while upholding the utmost standards of integrity.

At the very outset of our Masonic careers, we were all taught that if we should encounter a poor, distressed human being, pity should flow from our hearts and money from our purse. All Masonic charities are important and worthwhile, but perhaps none directly benefit the future of Tennessee more than the Grand Chapter's Autism, Assistance, and Aid Program.

As an educator, on a daily basis I see the impact autism and its related afflictions have on youngsters in our state. According to information released by the state to the U.S. Department of Education, more than 6,000

school-age children in Tennessee have been diagnosed with autism. There is no known cure for autism.

The mission statement of AAA is "to provide financial assistance to individuals, families, and support agencies who suffer from or provide aid to those afflicted with autism in its various forms within the State of Tennessee."

A definitive cause for autism has not been discovered, but researchers do know that early detection of the disease can help limit its impact. Studies suggest approximately 1 in 68 8-year-olds is autistic, more than double what it was in the year 2000. The symptoms of autism are generally noticed when a child is age 2-3, almost always by age 4. The characteristics include demonstrated difficulty with common social behaviors, difficulty with communication, and repetitive behaviors. Boys are five times more likely to be autistic than girls.

Statistically, every grade in every elementary school across the country has an autistic child.

That's where the Grand Chapter's Autism, Assistance, and Aid Program tries to help. In 2011, the United States spent an estimated \$9 billion on caring for children with autism. It is estimated that a family with an autistic child will spend \$60,000 a year caring for that child.

Through the Autism, Assistance, and Aid Program, any Royal Arch Mason in the state of Tennessee can make a request to get aid for an autistic child. Once the request is submitted, the AAA committee will validate the child's need for assistance, and then options of ways in which AAA can help will be determined.

The AAA program is funded annually by various means. One form of funding is the Samuel Pelmons AAA Challenge Award. The award is named in honor of the son of Royal Arch Mason Terry Plemons. The challenge measures giving based on dollar amount per member of an individual Chapter in the state. For example, if a Chapter with 100 members donates \$200, then that Chapter would be credited with a \$2 per member donation. The Chapter with the highest donation per member is honored each year during Grand Lodge week in Nashville.

Another method of funding the AAA program is through the Grand Chapter's certificate program. For each year of giving, an individual or Chapter will receive validation of their donation to hang on the wall of your home or meeting place. If an individual begins a donation plan, he will be presented with a lapel pin in the shape of a Royal Arch banner that signifies his donation level. Bronze is earned at \$100, silver at \$500, and gold at \$1,000. The pins are unique and can only be earned through the program by individuals who contribute to AAA.

Remember, donations to the Grand Chapter's Autism, Assistance, and Aid Program directly benefit and assist students and their families right here in the state of Tennessee.
